This document provides a step by step guide to completing your application for Affiliated Institute status.

The process consists of five main steps:

Completing the application - continued



Step 1: Check your organisation is eligible

There are several eligibility criteria that your organisation needs to meet in order to become a CII Affiliated Institute. These are as follows::

- Your organisation must have a vision or mission statement which aligns with that of the CII. This is typically one or two sentences outlining the intent of your organisation and what it is designed to achieve. - Your organisation must be not-for-profit. Many different types of organisations fit into this category but this would typically exclude private companies who are profit driven.
- Your organisation must be either an awarding body and/or a professional membership body and/or provide educational services. This essentially ensures that your organisation is sufficiently aligned to the work of the CII to become an Affiliated Institute.
- Your organisation must have the appropriate sector focus in order to become an Affiliated Institute with the CII. This means that it must be active

- in either general insurance, life and protection insurance or financial advice.
- 5. The organisation must be able to commit to working with the CII and other Affiliated Institutes to support the profession. From time to time, we may request your assistance with an initiative we looking to run in your region or on other projects where your knowledgeable insight would be of benefit.
- 6. In order to become a CII Affiliated Institute, your organisation must be able to demonstrate that it offers an appropriate programme of activity relative to the size of your market.
- 7. Your organisation must be able to declare that nothing about the organisation or its officers would create a reputational risk to the CII in being granted Affiliated Institute status.



Step 2: Complete the application form

Once you have confirmed that your firm is eligible to apply for Affiliated Institute status, the next stage is to complete the application form. This is split into two sections:

Section 1 - Your corporate details
 This section is all about your firm. We ask for details such as name, office address and contact details.

You are also asked who will be your Responsible Individual. The Responsible Individual's role is to be the primary contact for matters between the organisation and the CII. We also need a secondary contact and this should be someone we can contact if the Responsible Individual is unavailable.

In this section, you need to tick a box next to each of the aforementioned 7 eligibility criteria and another box regarding the terms and conditions. This is to confirm that your organisation meets these requirements and and that you agree to the terms and conditions.

Step 3: Submit your application

When you have answered 'yes' to all the guestions in the box below, you can submit your application form at internationalpartnerships@cii.co.uk





Step 4: Await the outcome of your submission

All applications go through a very thorough approval process, including requiring approval from the CII's Executive Management Team and the CII Board. Therefore approval can take up to 13 weeks from the date of submission.
